THE ESCAPE OF PRISONERS

It is disheartening to hear of the increasing numbers of prisoners escaping in the past few years. This project is closely intertwined with our previous project regarding corruption in South African prisons. Many aspects in that project lead to precisely this outcome: the escape of an increasing number of prisoners.

REASONS:

- The probable number 1 cause is corruption, where guards and Correctional Service officials are bribed to help with the escape plan.
- Prisoners are in close contact with other individuals who are masterminds in planning and execution.

- Syndicates pay enormous amounts of money for inside information:
 - Transportation routes, dates and times of prisoners to and from prisons and courts.
 - Technology allows prisoners to communicate with their associates on the outside:
 - Guards are bribed for mobile phones and laptops.
 - Escape plans can be extensively pre-determined while in prison.
 - Over-crowded South African prisons:
 - It is known that in many cases, guards are too scared to enter a cell where there are supposed to be about 40 prisoners, but there are actually between 70 – 120 prisoners.
 - This makes it difficult for prisoners to be counted and accounted for.
 - The overcrowding of, for example, trial awaiting prisoners at SAPS stations and courts allows for ideal opportunities to escape.

To catch the escapees, who are usually high profile, extremely violent criminals, rapists and murderers, has a knock-on effect of lost man-hours and resources, not to mention the financial costs involved. In addition, the guards place their own lives at stake when they are robbed of their firearms and sometimes brutally attacked when the prisoners try to escape. Moreover, their stolen firearms are again used in the prisoners' next criminal act.

POSSIBLE SOLUTIONS:

- The Department of Correctional Services has a daunting problem:
- Corruption must be rooted out at the lowest and highest levels.

- Overcrowding has to be addressed.
 - The number of trial-awaiting prisoners must be reduced – this is a massive problem as the backlog at the judiciary/courts is ever-increasing.
 - Fear, intimidation and bribery must be curbed.
 - Guards must be appointed via vetted recruitment processes, where they select ethical individuals.

We strongly recommend that you make up your minds concerning me and our organisation only after considering all the factual information - to the exclusion of hearsay and assumptions.

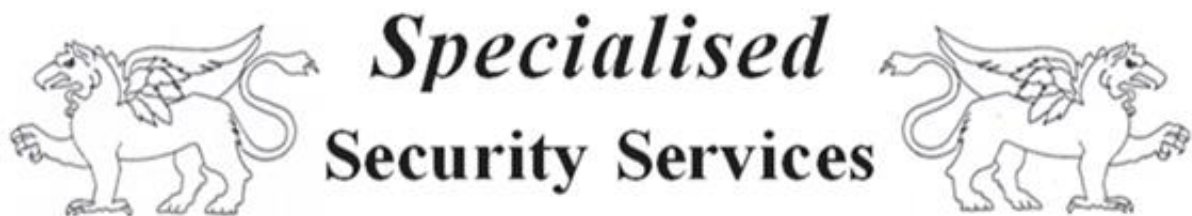
