



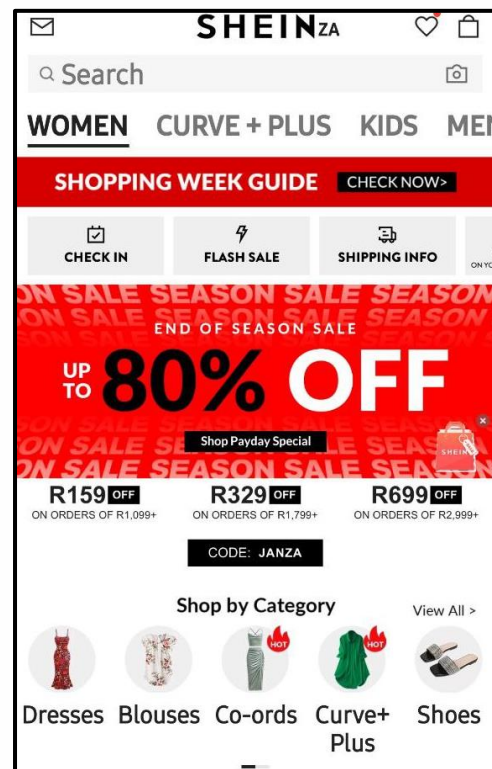
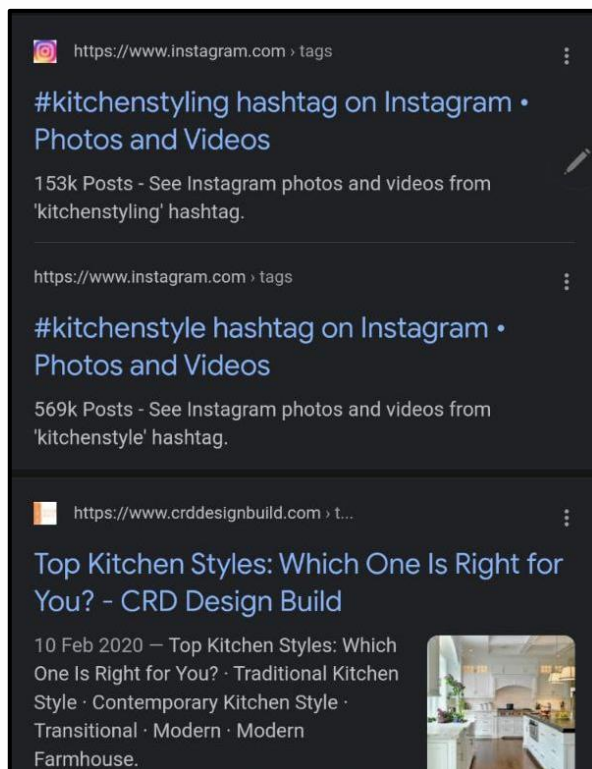

KNOCKS AND SCAMS

SHEIN @ KITCHEN STYLE



!!!!!!WARNING!!!!!!

- Shein shoppers are warned against the following scam by “Kitchen Style” through Shein on social media platforms.
- The shopper will be informed via a message on Instagram / Facebook or any other social media platform that they have won a shopping voucher from Shein.
- As the shopper does shopping on the Shein platform, it does not arise any suspicion with the shopper.
- Once the shopper clicks on the link provided to claim their voucher, the scammer accesses the shopper’s Shein account.
- After access to the Shein account was obtained, the scammer infiltrates the shopper’s bank card details on the Shein account and money is deducted.
- Deductions are made in small amounts, under R500.00 but can occur more than once.
- This is done not to awake immediate suspicion by the account holder.
- The shopper does not receive any message from Shein or Kitchen Style about the deduction.
- Furthermore no notification is received from the bank even if the profile does require a notification.
- Once shoppers notice money is missing from their account it might be days later and different deductions could have been made which also went unnoticed by the account holder.
- Shoppers are urged to monitor their bank accounts and to report such occurrences to the Fraud Department at their bank as soon as it is noticed.
- You are advised not to save any bank account information or card details on any online shopping app in an attempt to prevent such fraudulent transactions from happening.
- Should an investigation be required, do not hesitate to contact our organisation for help and advice.
