*The owners of the well-known Tammy Taylor Nails trademark are of the opinion that they are not engaged in any fraudulent transactions after their business undertaking has once again drawn attention over the past few months.*

- The participation of Mr and Mrs Viljoen in the television show, 'Die Real Housewives van Pretoria' has once again placed the spotlight on their business activities.
  - Carte Blanche also investigated their business.
  - They are now accused of buying generic products in Europe and repackaging them in South Africa with labels that they print locally.
  - They sell the products to their clients at their Tammy Taylor Nails salons, as if they are the original trademarked products.
  - The products include gel nail polish and powder used to create fake nails.

“Specialised Security Services” received proof that Tammy Taylor Nails Inc, United States had already terminated the Viljoen’s distribution rights in April 2022.

Specialised Security Services has received complaints against the business. These complaints include inter alia the following:

- Deposits between R172,500.00 and R300,000.00 paid to open a Tammy Taylor franchise.

- After paying a deposit for a license, no franchise was opened as per the contract signed.
- When a refund was requested, it was refused.
- Money was paid and accepted without a signed contract to open a franchise.
- No support *as per the contract* from the owners of Tammy Taylor Nails to assist the new franchisee - even though the franchise did not make a profit.
- If the franchisee complained, they were removed from the Facebook page.
- There was no advertising on any of Tammy Taylor Nails' web pages as was originally agreed upon.
- Numerous complaints pertaining the quality of the nails and nail art, gel and nail polish to mention a few were posted on social media.

- Peet Viljoen was known as Pretoria's celebrity lawyer a few years ago, though numerous complaints about his activities have been reported as far back as 2008.
  - He was disbarred as an attorney and has also been sequestered.
  - Viljoen is allegedly facing a total of 347 corruption, fraud and other related charges dating back to 2010. These charges involve selling Johannesburg Metro properties. He has already appeared in court and

his case has been transferred from the Pretoria North Court to the Specialised Commercial Crimes Court in Pretoria.
