In recent months, our cyber team at Specialised Security Services has uncovered a disturbing pattern of investment scams orchestrated by Rudolph Johannes Petrus De Meyer, also known as Rudi.

Born on February 11, 1980, Rudi has been operating under the guise of various investment companies, luring unsuspecting victims into fraudulent schemes with promises of lucrative returns.

- Rudi's companies, including Tree of Finance, Red Hot Industries, and Lazarus, have ensnared at least 26 victims, as far as our investigations have revealed.
- He initially gained the trust of these individuals with smaller investments before enticing them into larger ventures, all the while guaranteeing returns that seemed too good to be true.
- Our investigation, which started in October 2023, unequivocally identified Mr De Meyer as the mastermind behind these deceptive "investment opportunities."
- When confronted by the SSS cyber team, Rudi admitted to misappropriating funds from our clients and pledged to repay every cent.
- His plea for leniency and appeals to humanity fell flat when he failed to meet our conditions.
- The conditions were clear:
 - Transparency: Show the victims where their money went.
 - Ethical Practices: Refrain from trading with other people's money to perpetuate the cycle of deception.

Regrettably, Rudi could not fulfil these basic requirements, leading to the initiation of criminal proceedings with the South African Police Services.

- Unrealistic Promises:
 - Be wary of investments promising guaranteed high returns with little to no risk.
- Pressure Tactics:
 - Scammers often use pressure tactics to rush you into a decision without adequate time for due diligence.
- Lack of Licensing:
 - Ensure that the individual or company is licensed to operate in the financial sector.
 - Mr De Meyer, for instance, has no such license.

to be true, it probably is.*
